Word limit of abstract is strictly 200 words. Paper size shall be A4 size as per this template. Submitting author shall read and follow all necessary guidelines before the abstract submission. In addition, it is assumed that all authors are well aware about the contents in the manuscript about author's ethics, plagiarism, registration, presentation and publication before the submission. Use three to five keywords in alphabetical order separated with semicolons which will help readers to search and retrieve your paper through the internet. Keywords should ideally be phrases of maximum 1-2 words; single word keywords are also acceptable, but they may lead to many incorrect matches. (Times New Roman (TNR) 10, single line spacing)

2.1 Abstract and Keywords (TNR, 11 Bold)

Abstract shall describe the background of research or review, objectives, methods adopted, novelty of work, outcome/conclusion/summary of the work in brief. All these sections

should be presented appropriately. Word limit is strictly set as 200 words. Add three to five important keywords that helps for searching and indexing.

2.2 Body Text

Drafting an appropriately structured research manuscript is crucial for efficiently communicating research results, establishing credibility, and contributing to the knowledge advancement.

Prepare your research paper body text in simple 4 to 5 sections like Introduction, Methods, Results and Discussion & Conclusions. All section names must be numbered and typed as bold uppercase words.

2.	Methods	Explains how the research has been conducted, including the study, designs, participants, samples, materials, instruments used, and procedures adopted. Adequate detail shall be given so that fellow researchers could replicate the study.
3.	Results	Includes the outcomes of the study in a clear and structured manner. It may include text, tables, figures, and graphs to summarize the data collected and analyzed. Results should be presented objectively, while interpretation will be included the next section.
4.	Discussion	Interprets the results obtained in the research, link them with previous studies, and discusses their consequences. This section discussion ends with a summary of key findings and their significance.
5.	Conclusion	This section summarizes the key findings of the study and restates the importance of the research. It may also emphasize the broader implications of the outcomes and advise potential applications or areas for further investigation.
	References	The references section lists all sources cited in the paper, as per specified citation style.

In case of 'review paper', body text may consist of introduction, sections and subsections that focus on different aspects of the topic and conclusion. The body of the review paper should be organized logically and articulately, with smooth transitions between sections.

2.2.1 Sub subsections (TNR, 10 Bold)

Sub sections and sub subsections can be added appropriately and typed as bold title case words. They can be numbered as 2.1 and 2.2.1 as stated above.

2.3 References

- Check that all possible relevant and recent references are used and cited in the paper.
- There is no limit on the number of references.

- All references are numbered as [1], [2], [3], etc in the main body.
- Irrelevant self-citations should be avoided.
- Reference section should not be numbered.




Fig. 2. Adding equations




Fig. 3. Math type pop up window
