Guidelines

1. Conference Dates:

- AmityDXB MUN'25 will be held over three days, on the 9th, 10th, and 11th of May, 2025.

2. Rules of Procedure:

- The Rules of Procedure for AmityDXB MUN'25 are based on the the United Nations Association of the United States of America (UNA-USA) framework.

3. Eligibility Criteria :

- Delegates must be **14 years or older** to participate in MUN.

4. Registration Process:

- Schools must submit their School Delegation Registration Forms via [this link](https://forms.gle/i3H8kBAAnS8ecA1Tx6) to receive delegate allocations.

5. Eligibility Criteria for Best Delegation Award

- A school must have a minimum of 10 delegates participating in the conference to be eligible for the Best Delegation Award.
- A school delegation must be accompanied by a teacher for the entire conference and the Social Event. **Only one teacher is permitted to be present with the students.**

6. Registration Fees & Payment

- The registration fee per delegate is AED 200**, which includes participation in the Social Event, conference merchandise, and refreshments for three days.
- Payments must be made via bank transfer** to the University's account (details will be shared upon registration).

7. Committee Allocations:

- Committee allocations will be determined by the AmityDXB MUN Secretariat based on delegate preferences and prior MUN experience.

8. Awards & Recognition:

- We offer a range of prestigious awards, including:
 - Best Delegate**
 - Best Position Paper**
 - Best Draft Resolution**
 - Best Chair**

AmityMUN'25 Committee List

General Assembly Third Committee (SOCHUM)

- The United Nations General Assembly Third Committee (also known as the Social, Humanitarian, and Cultural Committee or SOCHUM or C3) is one of six main committees at the General Assembly of the United Nations. It deals with human rights, humanitarian affairs and social matters.

Economic and Social Council

- The United Nations Economic and Social Council (ECOSOC) is one of six principal organs of the United Nations, and serves as the central forum for discussing international economic and social issues, and formulating policy recommendations addressed to member states and the United Nations System.

United Nations Human Rights Council

- The Human Rights Council is an intergovernmental body within the United Nations system made up of 47 States responsible for the promotion and protection of all human rights around the globe. It has the ability to discuss all thematic human rights issues and situations that require its attention throughout the year.

International Court of Justice

- The International Court of Justice (ICJ) is the principal judicial organ of the UN. The Court has two functions: To settle, in accordance with international law, legal disputes submitted by States, and. To give advisory opinions on legal questions referred to it by authorized UN organs and specialized agencies.

Security Council

- The Security Council has primary responsibility for the maintenance of international peace and security. It has 15 Members, and each Member has one vote. The Security Council takes the lead in determining the existence of a threat to the peace or act of aggression. It calls upon the parties to a dispute to settle it by peaceful means and recommends methods of adjustment or terms of settlement.

UN Women

- The United Nations Entity for Gender Equality and the Empowerment of Women, also known as UN Women, is a United Nations entity charged with working for gender equality and the empowerment of women. UN Women is charged with advocating for the rights of women and girls, and focusing on a number of issues, including violence against women and violence.



International Press Corps

- Press corps committees are designed to represent the group of journalists typically present at the United Nations and other important bodies. At conferences, delegates in the press corps cover developments within GA and crisis committees. They organize and attend press conferences, interview delegates, and write articles to be published during the conference.

Futuristic Crisis Committee

- The FCC engages delegates in addressing hypothetical future scenarios, challenging them to anticipate and respond to emerging global crises. By simulating futuristic crises and exploring innovative solutions, the FCC promotes strategic thinking, crisis management skills, and collaboration among participants.
